## Call for Product Showcase Presentations

130th Annual IAOM Conference & Expo  
Cincinnati, Ohio, USA – April 14 - 16, 2026

You are invited to submit an application (or make a recommendation) for a Product Showcase presentation at the 130th Annual IAOM Conference & Expo in Cincinnati, Ohio. The IAOM Annual Conference is the premier education event in the milling and grain processing industries. The 2026 Conference offers **YOU** an exciting opportunity to address the industry's most active and influential professionals.

### Deadline to apply is December 15, 2025

The IAOM Product Showcase allows exhibiting companies at the IAOM Conference & Expo to promote products that are featured only on the exhibit floor. Selected presenters are given 10 minutes to conduct their presentations from their booths on the Expo floor on Wednesday or Thursday, April 15 or April 16, 2026.

### Eligibility Criteria

Acceptable products for the showcase must be either

- 1) **New and Innovative** – products introduced after May 2025 that are both new and innovative. Products must not have been previously exhibited at IAOM.
- 2) **Major Improvement, New Application** – products that show significant improvement in accuracy, cost, size, safety, ease of use, effectiveness, etc., or an existing product that has a new application for the milling industry.

### Submission Requirements

- Product must be from an exhibiting company at the 2026 IAOM Expo.
- Exhibiting company must be the manufacturer or exclusive distributor of the product.
- The product must be exhibited in the IAOM 2026 expo hall.
- Only products may be showcased; services are not eligible.
- All products must comply with FDA guidelines.
- Submit one application per product.
- A 75-word description (Microsoft Word) and high-resolution image (.jpg, .tif, .eps, .ai) must be submitted with the completed application. This will appear in the conference program.
- The description should be an informational paragraph, **NOT** an advertisement. The presentation should emphasize how the new product/service will improve/enhance milling operations.
- All Product Showcase presenters must have electricity in their booth at the IAOM Expo.
